3. Reports

a. Race

- i. Grand Prix. There was almost a sellout crowd. Thanks to all the approximately 150 DRSCCA volunteers. Next year, consider having ice bags outside the circuit to avoid hauling them over the bridge.
- ii. Gingerman SCCA Majors Race was profitable.
- iii. Next Gingerman Majors Race on July 8/9. 130 entries expected.
- iv. Empire Hillclimb, Sept 16 13 already registered. This is run under SCCA Time Trial Rules.

b. Rallycross

- i. Thistle Hill, May 27, had 51 entries, including 5 from the Hawaii region. The tentative final budget was presented, showing a profit around \$1,000. (See appendix 0).
