2. Reports

a. Race

- i. Gingerman SCCA Majors Race awaiting invoice for ambulance from Kim Bollinger, South Bend treasurer. Surplus was ~ \$20k.
- ii. Empire Hillclimb, Sept 16 30 already registered.

b. Rallycross

- i. Crystal Motor Speedway, August 12 final budget next month.
- ii. Thistle Hill, September 23.
- iii. November day/night event at Oakshade awaiting budgets.
- iv. December event at Thistle Hill.
- v. Jon Jareo is focusing on safety at these events.

c. Solo

- i. Before Nationals Oscoda, had some timing issues, 67 entries, surplus was \$428. (See Appendix 1, final budget).
- ii. Fall into Autumn MIS, budget motion to approve, Mike Nienhuis, 2nd Scott Harvey, unanimously approved. (See Appendix 2, budget).



iii. Season Ender – MIS, budget motion to approve, Jon Jareo, 2nd Scott Harvey, unanimously approved. (See Appendix 3, budget).

d. Rally

- i. Press On Regardless was a great success; used 11 of the 12 clocks we own.
- ii. Pavements Ends Rally, South Lyon Aubree's, budget motion to approve, Scott Harvey, 2nd Jon Jareo, unanimously approved. (See Appendix 4, budget).

e. Asst. RE

- i. Frank Putman, will work on the banquet, likely to be the first Saturday of February 2018.
- ii. Still looking for some awards from 2017.
- **f. RE** Setting up a date for a Budget meeting.

g. Treasurer

- i. At the end of July, we had \$125k cash on hand. This does not include the payment for FSAE of \$11,200, and Pro Solo reimbursement of \$5,363.
- ii. We may need to get a bookkeeper since Treasurer tasks are very time consuming. Perhaps we can query the membership for some help.

h. Membership

i. We have 1457 members, up 2 from last month. There were 23 new members and 21 lapsed. 9 September service awards were mailed out.

i. Equipment

- i. The Rallycross trailer outfitting is almost complete.
- ii. Renting of equipment Sno*Drift Rally will request clocks (to be used as backups). In return, they supply us with a quantity of batteries, usually enough for the year. Discussion commenced on whether to continue the trade or to change to a fee based rental. Currently, other RA events have been charged \$200 per event which should go to the Rally Budget. DRSCCA uses them 6 times/year; Rally America uses them 3 times/year. Per the Rental Agreement clocks must be replaced if they are lost or damaged. Clocks cost about \$200 each and the total replacement cost of our 12 clocks would be \$2,400, so renting them is financially reasonable, but care is taken to ensure we do not risk our own events.

j. Open Exhaust

i. Articles are needed. Aiming to next edition to be published by the end of October. Since event updates are regularly covered on Facebook etc., OE will be aimed more at individual stories.

k. Street Survival

 Fowlerville, Sept. 16, is oversubscribed with 30 students entered and 35 on the waitlist. We have been asked whether we could add another day. Maybe next year.
