1. Current Business

c. Solo

i. Memorial Day Solo – missing revenue information has been received so final budget will be completed.

d. Rally

- i. Cast in Stone, July 30 Good to see entries from outside our region. Harvey/Von Kaenel won with a record low score of 4! The event made a profit of about \$300.
- ii. POR starts Friday, September 9 in Indian River, MI.

e. Rallycross

- i. Thistle Hill need to get better directions on MyAutoEvents.com
- ii. Thistle Hill August 20.
- iii. Williamston (new site SE of Lansing), or Marshall as a fallback site October 1..

f. Treasurer

- BM presented the July 2011 Financial Statements. Notes to the Statements are attached in Appendix A.
- ii. Although the Jan through July P & L statement shows a \$14,000 loss, this will eventually reach breakeven when all the receivables shown in the Treasurers notes come in.

g. Assistant RE

- ii. Volunteers needed to help organize the Banquet.

h. Members at Large

- i. Solicit members to run for positions on the BODat the upcoming election.
- ii. Secretary to organize the balloting, including announcing the event on the website.

i. Equipment

- ii. Need for and requirements of a new trailer -

Current trailer (approx. 8.5 x 18ft) is too big for Funmover, and it needs some repairs.

Discussed closed vs open. Closed preferred because it is lockable, can be stored with equipment inside. Single axle, but with 5000lb option.

Need to know Funmover max towing capacity – Bob Martin?

3. New Business

a. Event Budgets

Rallycross Octoberfest, Oct 1, Williamston (new site). Motion to approve – Bob Martin, second – Bob Pierson, unanimous. If the event goes to Marshall, will make \$100 less since Porta-john is free, but site rental is \$200 more.

b. Street Survival

Fowlerville Proving Grounds to be held Sept 24. Need instructors. Eric P will attend a BMW CCA Street Survival event Aug 27 at Melvindale.

c. Entry fee refunds

Jennifer Merideth questioned the refund policy in the event that entrants failed to show up. There are non-refundable costs involved in processing the entry online and in making the refund. Should DRSCCA refund those costs out of their own funds? Bob Martin said our (Rallycross) policy is to refund all they paid in the interests of goodwill even though the "club" loses. Effort is made to have the entrant rollover the fees to the next event. In reality, there are very few refunds given so this does not appear to be a significant cost issue. The club policies cover this in section II, A 8 and 9 as follows:

"8. Entry refunds, minus any expense, will be approved by the Event Registrar and disbursed by the Treasurer. Refunds will not be made until checks have cleared the bank.

9. If a region event is cancelled by the region, the entry fee collected will be refunded in full, excluding any processing fees. In lieu of a refund, an entrant may elect to have the entry fee applied to a future event in that calendar year."

It appears that we are not doing what is in the policies. Since the consensus is to change the policy I will start a thread in the forum to discuss this.

d. The software used for Solo and Rallycross (AXWare?) needs review since it is not universal. Jen Merideth will form a sub-committee to review. Volunteers include JM, Nathan Usher, Bob Martin, Mary Shiloff (in absentia!)

e. Computer security

Advice for region computer security – Norton is a memory hog and noone likes it; Microsoft Security Essentials is used by some with no negatives; AVG is also free and appears to have a similar following.

f. It was mentioned that "Rallycross" is an SCCA trademark and SCCA is suing Tanner Foust for using it. Hmmm!
