## Appendix A

#### **DETROIT REGION TRAILERS**

The RallyCross program is in need of a medium sized trailer to transport its equipment to event venues. A 6 x 10 ft enclosed single axle (3500#) trailer pulled with the Funmover will meet these needs. A suitable used trailer has been purchased at less than  $\frac{1}{2}$  the cost of a new one. RallyCross is requesting an \$1800.00 budget to cover the purchase cost, registration/tags, and minor modifications.

#### BACKGROUND

When the Funmover was purchased to replace the existing truck, DRSCCA agreed to sell the old truck to Bob Martin. Bob has used his truck and DRSCCA equipment to start and develop the RallyCross program. Bob's truck has exceeded its useful life and a plan must be implemented to continue the RallyCross Program.

DRSCCA owns the Funmover and an 8 x 18 ft enclosed trailer. The Funmover is not equipped with a suitable hitch to safely haul the current trailer. The trailer is also too heavy to be practical.

#### **OPERATION**

This trailer will facilitate the distribution of cones and corner station equipment upon arrival at the venue. It is equipped with "barn doors" at the rear and a side door. The trailer can then be disconnected and the Funmover moved to the timing location. (This method is currently being tested by Mike McClintock for Solo utilizing an open trailer.)

The trailer will accommodate that equipment that is unique to RallyCross. In addition, it will accommodate those items that are common with Solo until agreements are reached that facilitate the use of such common items (loaner helmets, etc.).

Further changes will be required. The FunMover winter storage will need to moved to a location that is accessible. RallyCross runs monthly thru the winter.

#### **OPERATING EXPENSES**

Solo budgets currently cover the FunMover fixed costs and repairs. Those will now need to be shared by Solo and RallyCross on some apportioned basis such as mileage. Fuel costs will be covered by event budgets and the logbook procedure already in effect.

#### **FSAE**

The FunMover and RallyCross trailer, along with the timing equipment for both Solo and RallyCross will be able to transport all the equipment and cones required for FSAE.

#### **FUTURE**

The current 8 x 18 ft trailer has been used mostly used for equipment storage in recent years. This is redundant with the storage unit in Wixom. Should the trailer be sold?
