Policy ideas for worker retention – John Liesecki from MTM came in for discussion with BOD. In-depth discussion ensued, however main point is that workers want to be appreciated.

Race (Hal) – National race preparations going smoothly

Solo (Carrie) – Planning meeting with event chairs. All event chairs need a copy of the SCCA Insurance Handbook

Rally – (Jerry, for Dan) Next rally is Twilight Tour. Rally School on March 17. Rallycross on March 17. Moonlight Monte postponed until August. Jerry believes Couthard's Farm site as it was configured last rallycross (high grass, deep ruts) is not safe. Rallycross safety steward must review and approve site prior to budget approval

Treasurer – (Jerry) - Jerry will be delivering several reports to the BOD by e-mail each month. Jerry will put \$\$ from 2^{nd} checking account (~45K) into a 6 month money market account.

New Business

National Convention (Jen) – Paraplegic drivers school program being started by SCCA. BMW Street Survival Drivers school will be held in Detroit on May 12. Both groups are looking to partner with SCCA to put on these events. Both programs look worthwhile. Solo now requires Waiver steward, and Youth steward this year. Licensing is not required for these positions. Every event chair should have a 2007 SCCA Insurance book, and one should be in the funmover. There have been some changes to reporting requirements, so it's important for chairs to review the information.

Hotline (Jerry) – Jerry doesn't believe we are getting any value from the hotline (3 calls last month). Issue will be discussed at General Membership Meeting
