1. Current Business

b. Rally Cross

- i. had first event --65 drivers registered and competing 8 runs each. Looking for fuel number.
- ii. Test day at Milan Dragway scheduled. 2 potential sites. Can hold rallycross up to 49% paved will add to calendar if either site is useable. Only bad news is rental fee is high and entry may have to be raised to \$55. Ray reports that WKy hosts rally cross and auto cross at drag race site. Could investigate prepay – upfront discount.





Have to get sanction in and MSR – 18 days away. Jen motion to approve to cover sanction fees, Scott seconded Motion approve by voice vote.

c. Solo
