

Minutes of Board of Directors Meeting Wed. May 13, 2020

Meeting called to order at 7:10 pm.

1. Current and Online Business

- **a.** April 2020 minutes were approved online.
- **b.** Equipment Storage Pat Barber extended storage for the Funmover. Ken has the fire extinguishers; needs to know where to drop them off.
- c. Trophy Display Automotive HOF is no longer a candidate. Will table this, including a potential clubhouse, until a later date. Trophies are with Cindy. Ask Marcus if he can store them.

2. Reports

- a. Race (Nick Aranda)
 - i. WHRRI Drivers School possibly the last weekend of May.
 - ii. Detroit/WHRRI Regional Race June 27-28, budget was presented (Appendix 1). This will be the first race in Michigan this year. Item MSR Fees should read \$1204.50 which is 5% of \$24,090. With this change, a motion to approve was made by Jen Glass, 2nd Cindy Wisner, unanimously approved.

- **ii. MIS contact no longer there.** Trying to contact Jennifer Hutchinson re potential event on June 14. A budget was presented (Appendix 2). Motion to approve Ray Jason, 2nd Dan Assenmacher, unanimously approved.
- **iii. Test n Tune, June 5-7, Oscoda.** Budget was presented (Appendix 3). Motion to approve Keith Armitage, 2nd Cindy Wisner. Unanimously approved.
- iv. Summer Heat, July 5 at Schoolcraft, Ray Jason is Chair. Event is capped at 110 cars.

h. Membership report (Steve Balanecki)

- i. We still have members. We had 1332 as of 4/8 and have 1,327 as of 5/10. This is a loss of 5 members. The good news is we gained 15 new members since last meeting, which means 20 members either transferred or did not renew their membership.
- ii. Service awards 17 service awards were mailed at the beginning of the month.

i. Equipment (Ken Wiedbusch)

- i. Fire Extinguishers will not get them all certified due to event cancellations. Will have 16 inspected with curbside pickup. (Solo 8, Rallycross 4, Spares 4). Will send note to John Li if one is used.
- ii. Stove used for GP is 10 years old and need repairs. Will buy a new one from Sam's Club for \$600. (This is in Ken's budget, so no approval needed.)
