- a. Race (Nick Aranda)
  - i. Waterford Hills
    - 1. Working on date for Regional, but WHRR has not finished scheduling for the year.
    - 2. They will pay for their workers to be SCCA members.

### b. Rallycross (Matt Wolfe)

- i. 2005 Helmet good for another year.
- ii. Season Ender #11, Dec. 5, Milan Raceway. Very successful.
- iii. Crystal Motor Speedway Budget for Jan 2 event was presented (Appendix 2). Motion to approve, John Li, 2<sup>nd</sup>, Ray Jason, unanimously approved.

Discussion centered on the entry fee relative to the high cost of track rental. It was agreed to increase the entry fee to \$55 with non-member fee of \$70. Unanimously approved as amended.

### d. Rally (Piotr Roszczenko)
